1. Introduction

Our website, https://riwaqalquran.codestan.net (hereinafter: "the website") uses cookies and other related technologies (for convenience all technologies are referred to as "cookies"). 2. What are cookies?

3. What are scripts?

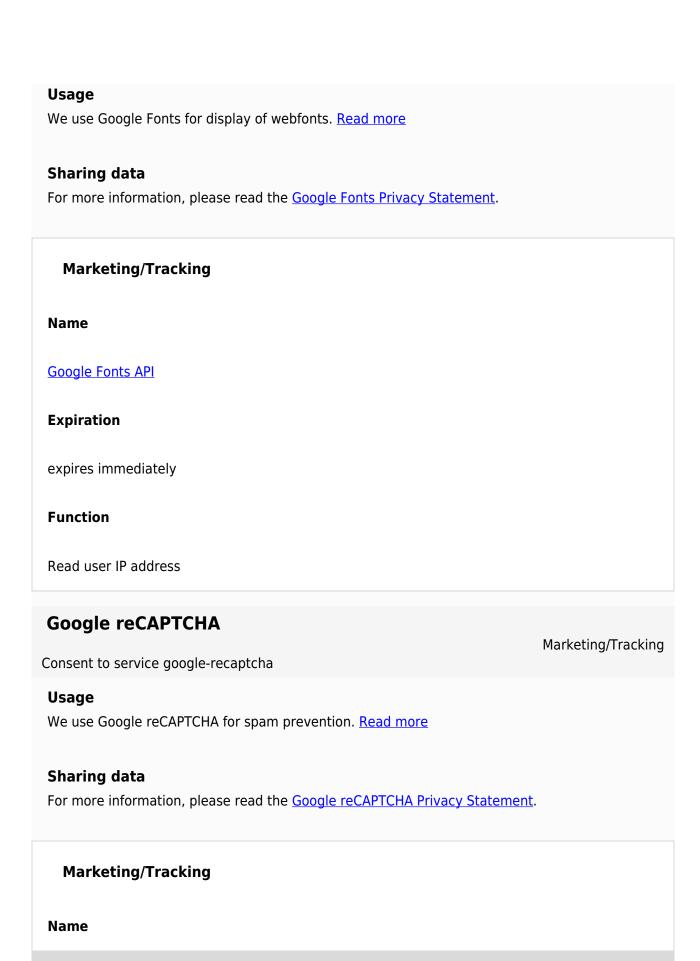

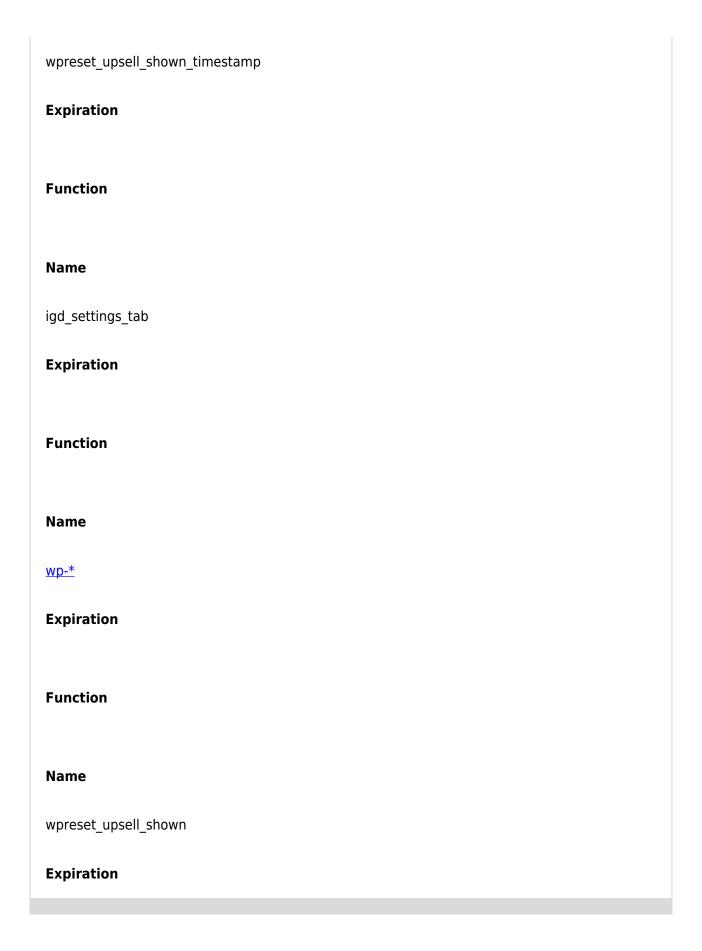
